In addition , in regulation is also regulated about unit education standard international , unit education based on superiority local , as well as organization education by representatives of foreign countries and cooperation unit education foreign with unit Indonesian state education .

PP Number 17 of 2010 concerning Management and Implementation education whereas Minister of Education, Culture, Research and Technology Regulation Number 47 of 2023 concerning Standard Management in Early Childhood Education, Elementary Education Level, and Secondary Education Level.

education pathways in Indonesia consist of levels education child age early childhood (PAUD), level education basic, level education medium, and level education tall. The PAUD level includes Kindergarten (TK) and Raudhatul Athfal (RA); level education base covering Elementary School (SD) and Madrasah Ibtidaiyah (MI) attended during six year to be continued with School Intermediate First (Junior High School) and Madrasah Tsanawiyah (MTs) which were taken during three year. Level education intermediate covering School Senior High School (SMA),

School Intermediate Vocational (SMK), and Madrasah Aliyah (MA). As for the levels education tall covering academy, polytechnic, school colleges, institutes, and universities.

Minister of Education, Culture, Research and Technology Regulation Number 47 of 2023 regulates management unit education that includes function planning, management, and supervision. Functions management the done to curriculum and learning, teachers and staff education, facilities and infrastructure, and budget. In addition to involving government and government area, management education in Indonesia can also be carried out by organizers unit education organized by the community or private sector.

At the end presentation, the speaker also discussed about existence regulation organization education by representatives of foreign countries. In regulations government the mentioned that representatives of foreign countries in the territory of the Republic of Indonesia are permitted to organize unit education Alone in accordance with system education in the country of origin. In this case, the implementation unit education the must through agreement The Government of the Republic of Indonesia. In addition, the unit education foreigners also not allowed accept student from circles Indonesian citizens. Currently, in several other countries, it has also there is Indonesia itself Already own Indonesian Overseas Schools or SILN which are located in shade Embassy of the Republic of Indonesia (Hendriansyah et al., 2024).

In addition, PP Number 17 of 2010 also regulates about cooperation unit education foreign with unit Indonesian state education. Cooperation This can be done by the unit formal education from PAUD level, education basic, education medium, to education high. As for the purpose from cooperation the is For increase quality education, expanding network partnership, as well as to organize unit education standard international or based superiority local.

Cooperation management education with foreign countries can be done in various formats. For example is exchange of teachers and personnel education or exchange students. Other collaborations can be done in implementation of twinning programs, utilization source power, or maintenance activity extracurricular. In addition, the unit education that is organized it is also mandatory involving teachers and staff Indonesian education. Participation at least 30% for teachers and at least 80% for power education. In various city big, cooperation management education like this already done in the form of school international or unit cooperative education (Hasanah, 2020). 


Figure 1. Documentation Session Management and Implementation of Formal Education in Indonesia
